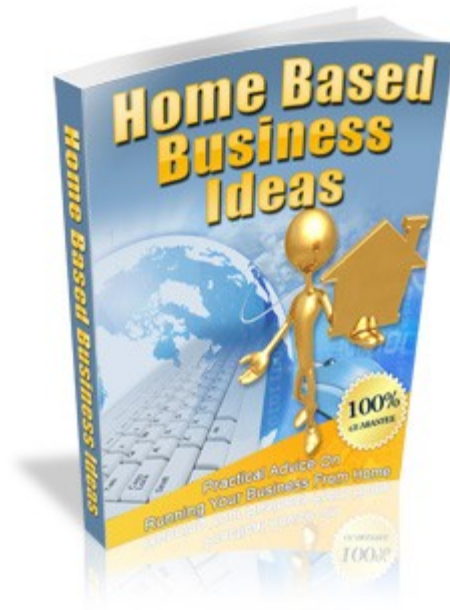

How It Works

Doctors and attorneys often send out this work rather than hiring someone to do it in house since it is less expensive to go that route. You will need to find a coding company to work through from home. Another option is to be hired by a doctor or attorney to do the work from home. In either option, you will need to local jobs in your local area or work from a larger online firm.

Potential Income

The amount of money you can earn from coding is dependent on where you work, who you work for, your location as well as your experience. Experienced coders will make more, as will those who work with multiple clients on a regular basis. Coders working full time can expect to earn \$35,000 or more per year on average. Those that work from home may charge around 70 cents per code that they do.

At Home Tutoring Home Based Jobs
